Turnover applies to all UK activities of the company registered. For multi-national companies, this will be clarified by using the denomination Name (UK).

Passivhaus Trust members will automatically be registered and their details shared with the [International Passive House Association](#) in accordance with iPHA's standard Terms & Conditions.

Passivhaus Trust members will appear on our website in our members' directory. Individual members may choose to opt out.

Membership applies to the company registered; this name will be used on all Passivhaus Trust materials. If Passivhaus activities are undertaken by a subsidiary company or division, these can be registered in their own name, but not in the name of the parent company.
