Members must refer to Passivhaus (or Passive House) Buildings and the components used in their construction exclusively as those buildings/components that fulfil the Passivhaus Standard criteria, as set out by the Passive House Institute, Darmstadt, Germany (see www.passivehouse.com). Turnover applies to all UK activities of the organisation registered. For multi-national companies, this will be clarified by using the denomination Name (UK).

Passivhaus Trust members will automatically be registered and their details shared with the [International Passive House Association](#) in accordance with iPHA's standard Terms & Conditions.

Passivhaus Trust members will appear on our website in our members' directory. Individual members may choose to opt out.

Membership applies to the organisation registered; this name will be used on all Passivhaus Trust materials. If Passivhaus activities are undertaken by a subsidiary company or division, these can be registered in their own name, but not in the name of the parent company.
